

- ✓ Registration of acts on the audit.










COLLECTION AND PROCESSING OF USED PETROLEUM PRODUCTS VIA WRA

WRA'S DRAFT PROGRAM ON THE ORGANIZATION OF STORAGE POINTS AND PETROLEUM REFINING FACILITIES










Waste oil collection points of various configurations and equipment (Volume from 1m³ to 26m³)

Points for the separate accumulation of waste oils at the sites of members and partners of the Association
















Large-tonnage automated point for the accumulation and issuance of waste oils of the Repair Depot of the Russian Railways









EQUIPMENT

The plan itself is a modular complex mounted on the basis of two hull frames (with dimensions and transport fastenings matching a 40 ft HC sea container), inside which the main parts of the equipment are fixed, which allows for autonomous work and has the ability to be transported to a place where complex of works is necessary.

Implementation of mobile plants for processing petrochemical products of various compositions

PURPOSE




Production of base oil components and bitumen plasticizers in logistical accessibility from the places of accumulation of petrochemical raw materials, including waste oils

TECHNOLOGY



Vacuum separation of a mixture of pre-normalized petrochemical raw materials into target products - an oil component and a bitumen plasticizer. By-product - light fraction is used at the plant as a burner fuel
